PreK3 Full School Day Program Tuition, Fees, and Requirements

Tuition Rate: \$7,000.00 or \$700.00/10 months

Enrollment Fee: \$250.00 (*Enrollment Fee is Non-Refundable and due annually*)

Requirements and Documents

- Child must be 3 years old on or before Sept. 1, 2024
- Child must be fully toilet trained (NO pull ups)
- Child will wear PreK uniform (not provided by school)
- GSCS application submitted online
- Birth Certificate must accompany application
- Baptismal Certificate, if the child is baptized Catholic, must accompany application
- State of Florida Department of Health Physical (FL DH 3040) and Immunizations (FL DH 680) forms must accompany application

PreK3 Full School Day Program Highlights

- All classrooms have a Teacher and Assistant, based on student-teacher ratio.
- Program Hours: School Days August through May, 7:50a.m. to 2:55p.m. (1:55pm on Wednesdays). Daily naptime is part of the schedule.
- Enrichment classes include: Music, Physical Education, Art, Spanish, and Technology/Media.
- Students are expected to bring lunch, a water bottle, and a healthy snack daily.
- Parents, Teachers, and School Administration work together to form a positive partnership in a Catholic environment.
- PreK3 program days, vacations, and holidays run concurrently with the school. A detailed school calendar is published on the school website, www.goodshepherd.org, and available to parent/guardians via the Family Portal.
- Extended Care is available at an **additional cost** (see Extended Care Flyer for details).
- Tuition is paid through the FACTS program annually or monthly on the 5th, 10th, 15th or 20th of each month, August through May. There is a \$46.00 annual administration fee, per family, charged by the FACTS program. There are no tuition discounts available for PreK3 tuition. PreK3 costs qualify as Child Care Credit.
